 - **Explain purpose of General Business Meeting**
 - PRIMETIME is a Group, registered with Central Office
 - The main purpose of the GBM is to keep all members of the Group (Primetime) up to speed on what is happening in the Group
 - Groups have regular General Business Meetings - every other month (to be voted on by the group).
 - General Business Meeting Attendees:
 - Steering Committee members (required)
 - Meeting Secretaries (or elected Meeting Representatives/Alternates) from each meeting that is a part of the group (required)
 - Bring information to and from the individual meetings to the Group
 - Ensure that each meeting has a voice
 - Any member of the Group who wants to attend
 - What happens at a GBM?
 - Motions can be brought
 - Motions are usually as it concerns the individual meetings.
 - Examples:
 - Changing anything on their format (other than Primetime Preamble)
 - Changing meeting length
 - Choosing speakers
 - 7th tradition money from a meeting
 - Any individual question a secretary might have and needs to bring to the Group as a whole.
 - Issues are first discussed at the meeting level where they take their own group conscience, which is then brought to the GBM.
 - **Explain purpose of Steering Committee**
 - The Steering Committee is a smaller group of elected people who are trusted by the group conscience to make decisions for the group as a whole.
 - Steering Committee has regular meetings (usually once a month).
 - What types of issues does the Steering Committee address?
 - Group 7th tradition funds
 - Venmo receipts
 - Paypal receipts
 - Individual meeting contributions
